- 1) The Customer Charge is a fixed monthly charge per General Service customer and primarily covers costs that do not vary by level of usage.
 - 2) The "GCA" is the rate component that covers the cost of gas supplied to the customer. Sycamore does not earn a return on the GCA.
 - 3) The "FMCA" is the Federally Mandated Cost Adjustment and is computed in accordance with the provisions of IURC Order in Cause No. 45131.
 - 4) The Distribution Charge is the charge that covers all remaining costs and decreases by level of consumption.
